

# **ALERT! DE's HB 230**

This legislation will be heard and voted on in the 2024 Legislative Session in Dover. It allows for the medical experimentation, sterilization, and mutilation of children.

HB230 gives the State of Delaware "emergency jurisdiction" of a child who isn't able to obtain transgender interventions. Meaning, the state would have the authority to legally take a child from a parent who affirms the God-given identity of their child rather than bowing to the societal and cultural pressures of the day.

20 states and counting have already banned transgender interventions for children. If any children come to Delaware from those states, Delaware will also take "emergency jurisdiction" over them to make sure their "transition" (medical experimentation, sterilization, and mutilation of children) is allowed and paid for.

The case was highly publicized (Nat'l Geographic 2017) and put Delaware on the map for state taxpayer funding (Medicaid) transitioning of a child.
