

KNOW YOUR RIGHTS AS A PARENT

As parents, God has entrusted us with the responsibility to guide, protect, and disciple our children. The U.S. Supreme Court (Mahmoud v. Taylor) recently affirmed these rights by ruling that public schools must respect families' sincerely held religious beliefs—especially on matters involving sexuality and gender identity.

1 YOU HAVE THE RIGHT TO:

- Opt your child out of LGBTQ+ and gender-identity instruction
- Decline surveys that ask about gender, sexuality, or identity
- Protect your child from pronoun mandates or compelled speech
- Receive advance notice when sensitive content is being taught
- Expect no punishment or retaliation for exercising your rights
- Request a written plan from the school outlining how your opt-out will be respected

2 WHY THIS MATTERS FOR THE CHURCH:

Church families are not powerless. This ruling reinforces what Scripture teaches: “Train up a child in the way he should go...” (Proverbs 22:6) You have **BOTH** the biblical authority **AND** the constitutional protection to guide your children faithfully.
